

TOURIST(C-3-9) VISA – up to 90 days

- * Please visit our website www.koreasydney.net for general visa information.
- * It takes [minimum 7 business days](#) for visa processing and do not return documents once submitted.
- * Visa application is only available between [9am to 12pm, Monday to Friday](#) (Public Holidays excepted).
- * Please note that Consulate General of the Republic of Korea in Sydney may request an applicant to submit additional documents and **it may affect a delay on your visa processing time.**
- * Do **NOT** call/ email us to check your visa status that causes processing delay.
- * Providing incorrect information may cause a visa refusal.

TOURIST VISA (C-3-9)	
An applicant who is going to stay for a short period of time(less than 90 days) for transit, tourism, visiting relatives and friends, shopping or other reason similar to these. Profitable activity is not allowed in this visa condition.

REMARK	
<input type="checkbox"/>	Original Passport 1) More than 6 months of the validity is required. 2) A photocopy of passport (biographical info page) is required.
<input type="checkbox"/>	Passport-sized Photo <u>Please attach the photo on the visa application form.</u> / Must be taken in 6 months. (photo section, page 1, size: 3.5cm x 4.5cm) White or Off-white background photo/ Paper-printed photograph will not be accepted.
<input type="checkbox"/>	Visa Application Form Please go through every single page (5 pages in total) of the application form carefully. Applicant's signature has to be same as the one on the passport.
<input type="checkbox"/>	Australian Visa Status You must provide a proof of valid Australian visa such as visa grant notice and VEVO etc. If you are holding a bridging visa, please submit a Bridging B visa that allows you to travel outside of Australia. (some of countries satisfied 2 year residency in Australia)
<input type="checkbox"/>	Flight Itinerary Round trip flight itinerary is required. It must book under applicant's name.
<input type="checkbox"/>	Proof of Residence You are required to provide your address during your stay in Korea. If you have a family or friend to stay with, you can provide a copy of their Photo ID with their address on it. Otherwise, you MUST submit an accommodation booking confirmation.
<input type="checkbox"/>	Australian Bank Transaction Lists List of transactions under applicant's name for the most up-to-date 3 months are required and the closing balance should be more than AUD\$3,000.
<input type="checkbox"/>	Visa Fee We do NOT accept a company or personal cheque. In case of lodgement by post, money order is preferred.
<input type="checkbox"/>	Prepaid Return Envelope Only required when you apply for a visa by mail. Express post envelope is preferred (Please write your address clearly on the envelope for a safe return of your passport).

*** If you fail to comply with any one of above documents at time of visa lodgement (in person or by mail), we will STRICTLY return your visa application documents (Online submission will NOT be accepted).**
